 - No changes to All Star Games
 - No more 50/50—they are adding \$350 to each team—teams can still do 50/50 if they want
 - Father McGivney will not have a team this year but will the following year
 - Mascoutah will have a JV team this year
 - Draft date is August 15 paperwork, team needs to commit by August 11
 - JV proposal submitted
- Fundraising committee: Barbie, Rachel, Tonya. Stephanie met in July
 - The fundraising committee has proposed several items. We have decided to order 100 blankets from teamthrows.com. Barbie proposed to order 100 blankets to sell to club members and their families. 2nd: Tonya. Proposal passed and Stephanie P will order blankets.
 - Other fundraising ideas: To have a portion of the grocery raffle ticket sales go to individual player fees.
 - To give families money toward player fees if they work a shift at Schweizerfest.
 - Other ideas: Game day banners to hang up at HHS & HMS and obtain sponsors to pay for students to get into games. Do a vinyl vertical banner thanking our sponsors. Talked about doing a trivia night, Goldfish races and possibly a chicken & beer dance.
 - Each throw blanket will be \$30.
 - Create a google form with a QR code to the blankets

Financials discussion and recommendation: Kevin

- Kevin looked into QuickBooks. It will be \$420 per year. There was discussion around acquiring that for the club. **We have decided not to do this.**
 - Kevin proposed a flat rate of \$1,000 per player for the 25-26 season. It will still be a \$500 fee for goalies. The proposal passes unanimously.
 - Kevin also brought up becoming a 501c3 and looked into doing the legwork. We are currently unincorporated.
- Kevin and Stephanie discussed TeamSnap and an option for a website. The website cost would be \$500 in addition to what we already pay.
 - Kevin proposed paying TeamSnap and the domain for \$500. 2nd: Barbie
 - Proposal passed and Kevin will purchase

NEW BUSINESS:

- Alumni game–November 29th at EAIA
 - **Someone new to chair?** Let Donny Know if you'd be interested in spearheading this event. Barbie will send an email to the club asking for anyone new to chair and/or shadow Donny & Jill Gunter this year. So far, nobody has stepped up.
- New HBHC banner
 - Ryan Perrine to look into a cloth banner. Cost is approx \$200 and it's a 2 week turnaround. 2 sizes to choose from: 8"x4" or 10" x 4"
- Workouts with Colin
 - Average of 11-13 attending each session per CJ in June
 - From mid June to mid July averaging 15-16 players
 - From mid July to mid August averaging about 15 players per session
- Discuss committees to work on fundraising and handbook
 - Handbook committee: Donny, Stephanie, Steve has not met
- Schedule team pictures earlier with Voegele
 - We have two dates penciled in- September 25th and October 2nd from 5p-6p. Will do Sept 25th if jerseys arrive on time. If not, we will do Oct 2nd.
- Gun raffle
 - Gun raffle tickets, we have 11 left. Do we want to sell the rest or draw now?
- Golf tourney
 - Golf tournament next year will be July 25, 2026 at Oakbrook. Andy Ammann to chair this again. We have approx 10 more hole sponsors than last year. Still down a few teams to be sold out.
